

## Collaborative Practice San Diego Professional Membership Application

Membership in the Collaborative Practice San Diego ("the Association") shall be by application followed by the recommendation of the membership committee and if there is no objection by an existing member of the professional level group within 5 business days after the application is submitted to the professional level group by the membership committee, then the prospective member automatically becomes a member. If a member of the professional level group objects or requests a debate, then the issue is placed on the agenda for the next general meeting and is voted upon. Members are expected to attend and participate in the general meetings and other activities of the Association. In order to become and remain a member of the Association an individual shall:

- 1. Complete a basic (minimum 2 day) "Collaborative Divorce" training program meeting the standards approved by the International Academy of Collaborative Professionals ("IACP").
- 2. Join and maintain a membership in the IACP (reduced dues paid through the Association).
- 3. Agree to abide by the "Ethical Standards for Collaborative Practitioners" developed by the IACP.
- 4. Maintain all licenses and certifications to permit the member to practice his or her profession in the State of California, carry professional liability insurance, and immediately notify the Board of Directors of (a) any change in the status of these licenses or insurance and (b) any official finding by the professional's regulatory body of any ethical violation or disciplinary action.
- 5. Meet the following minimum standards for experience in each discipline:
  - a. Mental Health be licensed, and have 5 years experience in his/her field since becoming licensed, or equivalent experience (as determined by other mental health practitioners of the Association);
  - b. Attorney be licensed to practice law in the State of California, and have at least 5 years experience since becoming licensed during which time his or her primary focus has been family law, or equivalent experience (as determined by the other attorney members of the association); and
  - c. Financial (i) be certified as either a CERTIFIED FINANCIAL PLANNER PRACTIONER (CFP) or Certified Public Accountant (CPA) with 5 years experience post-certification; and (ii) substantive experience in the financial aspects of divorce within the past 2 years.
